

# TERMS OF USE OF PORTAL

THIS AGREEMENT GOVERN YOUR RELATIONSHIP WITH EUROASIAN RAIL STRING SYSTEM HOLDING V LTD. AND USE OF PORTAL AVAILABLE ON BUYSWS. COM AND/OR SELLSWS.COM ("PORTAL") AND ANY DOMAINS INCLUDED WITHIN THIS PORTAL PROVIDED TO YOU BY THE COMPANY. YOU MAY USE THIS PORTAL ONLY ON THE CONDITION THAT YOU ACCEPT ALL OF THE TERMS AND CONDITIONS CONTAINED HEREIPN. PLEASE READ THESE TERMS CAREFULLY BEFORE USING THIS PORTAL. USING THIS PORTAL INDICATE THAT YOU ACCEPT THESE TERMS. IF YOU DO NOT ACCEPT THESE TERMS ("TERMS OF USE"), DO NOT USE THIS PORTAL. #### GENERAL TERMS AND ACCEPTANCE OF THIS AGREEMENT

- 1. The Company makes this Portal including all information, graphics, documents, text, products and all other elements of the Portal and all products offered on this Portal, available for your use subject to the terms and conditions set forth in this document and any additional documents available at the Portal. By accessing and using this Portal or clicking a checkmark at the "I agree with the Terms of Use" button and pressing "Next" button you agree to be bound by the following Terms of Use and all terms and conditions contained and/or referenced herein or any additional terms and conditions set forth on this Portal and all such terms shall be deemed accepted by you. If you do NOT agree to all these Terms of Use, you should NOT use this Portal. In addition, specific terms and conditions may apply to specific content, products, materials, or information contained on or available through this Portal (the "Content") or transactions concluded through this Portal. "Parties"	You (User) and the Company (We).
"Politically exposed person" or "PEP"	Foreign PEPs: individuals who are or have been entrusted with prominent public functions by a foreign country, for example Heads of state or Heads of government, senior politicians, senior government, judicial or military officials, senior executives of state owned corporations, important political party officials.  Domestic PEPs: individuals who are or have been entrusted domestically with prominent public functions, for example Heads of State or of government, senior politicians, senior government, judicial or military officials, senior executives of state owned corporations, important political party officials.
"Privacy Policy"	Rules of collection, storage, distribution and protection of personal data that the Company gets from the Users and that is an essential part of the Agreement which text is available at Portal.

- g) A reference to a statute or statutory provision is a reference to it as amended, extended or re-enacted from time to time.
- h) A reference to a statute or statutory provision shall include all subordinate legislation made from time to time under that statute or statutory provision.
- i) A reference to writing or written includes fax and e-mail.
- j) Any obligation on a party not to do something includes an obligation not to allow that thing to be done.

## **RISKS NOTIFICATIONS**

- 7. Cryptocurrency trading also has special risks not generally shared with official currencies, goods, or commodities in a market. Unlike most currencies that are backed by governments, other legal entities, or commodities such as gold or silver, Cryptocurrencies are a unique type of "fiat" currency, backed by technology and trust. There is no central bank that can issue more currency or take corrective measures to protect the value of Cryptocurrencies in a crisis.
- **8.** Cryptocurrencies are unlike bank accounts or accounts at some other financial institutions are entirely uninsured.
- 9. User acknowledges that there are risks associated with using of the Portal, including but not limited to, the failure of hardware, software, and Internet connections. User acknowledge that Company shall not be responsible for any communication failures,



- disruptions, errors, distortions or delays You may experience when using the Portal however caused.
- 10. SWS Tokens may be held by the User in his digital wallet or vault, which requires a private key, or a combination of private keys, for access. Accordingly, loss of requisite private keys associated with such the User`s digital wallet or vault storing the SWS Tokens will result in loss of such SWS Tokens, access to User`s Account, and/or any initial balances in blockchains created by third parties.
- 11. Blockchain technologies have been the subject of scrutiny by various regulatory bodies around the world. The functioning of the Ethereum network and associated blockchain networks and different Cryptocurrencies could be impacted by one or more regulatory inquiries or actions, including but not limited to restrictions on the use or possession of any Cryptocurrency, which could impede or limit their existence, permissibility of their use and possession, and their value.
- 12. The tax characterization of the Cryptocurencies is uncertain. The User shall seek his own tax advice regarding the SWS Tokens, which may result in adverse tax consequences for the User, including, without limitation, withholding taxes, transfer taxes, value added taxes, income taxes, and similar taxes, levies, duties or other charges and tax reporting requirements.
- 13. There may be additional risks that we have not foreseen or identified in our Terms of Use.
- **14.** You should carefully assess whether your financial situation and tolerance for risk are suitable for buying, selling, or trading Cryptocurrency.

## **ELIGIBLE USERS**

- **15**. The following restrictions and conditions apply to the use of Portal and creating and maintaining the Account (as such term defined below):
  - a) You shall not create an account in connection with the Portal (an "Account") if you are under the age of majority to enter into this Agreement (at least 18 years of age) and meet all other eligibility criteria and residency requirements and fully able and legally capable to use the Portal.
  - b) You shall not use the Portal if you are a PEP or any member of a PEP's family or any close associate of a PEP, unless the Company, after being specifically notified in writing that the User is such a person, conducts further due diligence, and determines that You are eligible for use of the Portal.
  - c) You shall monitor your Account to restrict use by minors, and you shall deny access to children and teenagers under the age of 18. - e) You shall not have an Account if you have previously been removed by the Company from the Portal.
- f) You shall not use Portal if you are citizen or resident of: Afghanistan, Algeria, Andorra, Australia, Bahamas, Bangladesh, Bolivia, Bosnia and Herzegovina, Botswana, Burma, Burundi, Canada, Cayman Islands, China, Cuba, Egypt, El Salvador, Estonia, France, Germany, Gibraltar, Guyana, Hong Kong, Iran, Iraq, Italy, Japan, Jordan, Korea DPR, Korea, Republic, Kyrgyzstan, Lao, Lebanon, Liechtenstein, Lithuania, Luxembourg, Malaysia, Malta, Mexico, Mongolia, Nepal, Netherlands, New Zealand, Nicaragua, Nigeria, Norway, Pakistan, Panama, Philippines, Qatar, Samoa, San Marino, Saudi Arabia, Singapore, South Sudan, Sri Lanka, Sudan, Switzerland, Syria, Taiwan, Trinidad and Tobago, Tunisia, Uganda, United Kingdom, United States and depending territories, Vanuatu, Venezuela, Yemen, Zimbabwe and countries or territories or individuals under the sanctions of the United Nations or the European Union or countries where cryptocurrency is prohibited.
- g) You shall not use your Account to advertise, solicit, or transmit any commercial advertisements, including chain letters, junk e-mail or repetitive messages (spim and spam) to any other user or third party.
- h) You shall not use your Account to engage in any illegal conduct including but not limited to activities related to money-laundering, drug trafficking, human trafficking, weapon trafficking, terrorism, securities fraud, or tax evasion. The User represents and warrants that he/she will not use the Portal to assist any other party in such illegal activity; and you shall not use your Account to: distribute spam, junk communications or chain letters; reverse engineer or otherwise improperly access any of the Portal's or the platforms underlying code or technical mechanisms; cause damage to the Portal or the Company through any means, including (but not limited to) through the use of malware, viruses, illegitimate credentials, phishing, brute force attacks, SQL exploits, or any other method of detrimentally intercepting, interrupting, or damaging any information or functionality related to the Portal.

  - User has failed to comply with Terms of Use and/or fulfil its obligations before the Company;
  - b) User has submitted incorrect and/or false and/or misleading information/documents to the Company;
  - c) Signatory right of User's representative has expired;
  - d) The Company suspects that User or funds available on Account are related to the laundering of funds derived from criminal activities or terrorism, or funds available on Account are unlawful or operations are made in benefit of PEP.

- 20. No communication or information provided to you by the Company is intended as, or shall be considered or construed as, investment advice, financial advice, trading advice, or any other sort of advice related to purchase of SWS Tokens. Before purchasing SWS Tokens, you should conduct your own due diligence and consult your financial advisors before making any investment decision. The Company will not be held responsible for the decisions you make to buy, sell, or hold SWS Tokens.
- 21. EXCEPT AS EXPRESSLY PROVIDED TO THE CONTRARY IN A WRITING BY US, OUR PORTAL IS PROVIDED ON AN "AS IS" AND "AS AVAILABLE" BASIS. #### LIMITED RIGHT OF USE

- **36.** This Agreement shall be governed, construed, and enforced in accordance with the law of Cayman Islands.
- 37. The Parties will tend to solve all disputes, differences and claims that can arise out of the execution, termination or cancellation of the Agreement by means of negotiations. The Party that has some claims should send a notification to the other Party describing the arisen claims and/or differences. In case of no agreement during negotiations, the Party shall send a claim to the other Party. The party receiving the claim is obliged to respond in writing to it within 10 (ten) days from the date of receipt.
- **38**. Any dispute, controversy or claim arising out of or in connection with this contract, or the breach, termination or invalidity thereof, shall be finally settled by arbitration in accordance with the Arbitration Rules of the Riga International Commercial Arbitration Court in Riga on the basis of written documents (written procedure).
- **39.** The number of arbitrators shall be one. The language to be used in the arbitral proceedings shall be English.



#### INDEMNIFICATION

40.
